The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 10/16/2020 at 0109 hours suspecting that the driver was either ill, fatigued, or impaired I conducted a traffic stop on a white 2018 GMC pickup truck, FL tag PIHP98 after I observed the vehicle drifting as it traveled northbound on MacDill Av N from Kennedy Bl W and then make an abrupt right turn on a red traffic light(at Cypress St W) without slowing down. Upon contact with the driver of the vehicle, defendant Jesse Luke Blackstock, I observed that he had glassy bloodshot eyes and then as I explained to him why I had stopped him I detected a distinct odor of an alcoholic beverage. The defendant then admitted to drinking at the Armature Works. The defendant then exhibited additional signs of impairment during the SFSEs. At which time I placed him under arrest for DUI based upon all of my observations made thus far in my investigation. The time of arrest was 0127 hours. I then transported the defendant to the HCSO/CBT Facility where he refused to submit to a breath test. Implied Consent was read at 0201 hours. I identified the defendant with a valid FL DL. He was the only one in the vehicle.
