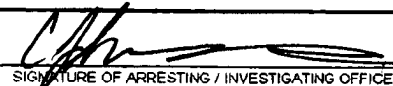

STATEMENT	The following incident occurred in the City of Riviera Beach, Palm Beach County, Florida. I utilized my axon body worn camera. On Friday, August 29, 2022, at approximately 23:59 hours, I responded to 1160 Singer Dr in reference to a 911 hang-up. Upon arrival, I made contact with Taylor Wilson (W/F, 10-22-1992) outside of the residence. It should be noted that Riviera Beach patrol units received a previous 911 hang-up and dispatch could hear a commotion in the background. The following is a synopsis of what occurred per Wilson's statement: Wilson in a sworn recorded statement said that she was arguing with her boyfriend Jesse Wiggins (W/M, 12-07-1979). Wilson and Wiggins have been in a 5-year intimate relationship and living together since late December of 2021. Wiggins was in the living room playing the Xbox video game console, while Wilson was in the bedroom. Wilson could hear Wiggins talking about her to his friends through the video game. Wilson stated she exited the bedroom and walked into the living room. Wilson told Wiggins to stop speaking about her with his friends. Wilson then became upset because Wiggins began to record her with his cell phone. Wilson took Wiggins's cell phone, placing it down without touching Wiggins's person. Wiggins then pushed Wilson in her chest area causing her to fall onto the couch. Wilson stated she then tossed the glass table onto the ground causing it to break. Wilson said she later began cleaning up the glass due to having a pig in the residence as a pet. Wiggins began arguing with Wilson in the hallway. Wilson then attempted to retrieve her cell phone from Wiggins, who was inside the bedroom with the door closed. Wilson unable to gain entry to the bedroom, attempted to kick the door open but was unsuccessful. Wilson stated that

Wiggins exited the bedroom pushing her from entering the bedroom that they share. I observed fresh red markings on Wilson's neck and chest area that she received from Wiggins pushing her. Wilson denied being strangled or punch with a closed fist. After contacting Wiggins via cell phone, I was able to get Wiggins to exit the residence. It should be noted that Riviera Beach Communications informed responding patrol units that Wiggins was barricaded inside of the room with the door closed. Wiggins in a sworn recorded statement said that Wilson was acting unusual. Wiggins said that Wilson was attempting to enter the bedroom after an argument. Wilson was charging towards the door attempting to kick the door off the hinges. Wiggins said he was blocking the doorway and pushing Wilson backward to prevent Wilson from entering the bedroom, due to the arguing. I canvassed the residence and observed furniture and items appearing to be out of place and damaged. It appeared as if a struggle took place from the living room to the bedroom. I also noticed the nightstand being used to block the bedroom door. I took photos of the inside of the residence and observed broken glass in the living room and bedroom. I also took photos of Wilson and Wiggins's injuries and uploaded them into evidence. Based on Wilson and Wiggins's statements, Wiggins was placed under arrest for 1 count of Simple Battery Domestic. Wiggins was transported to St. Mary's hospital for medical clearance due to a bruised right index finger. Wiggins was processed and later turned over to Palm Beach County Sheriff's Office for booking.
