The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did I observed the defendant driving a white Mercedes with FL tag JHAH49. She was traveling west on W. Horatio St towards Armenia Ave at a high rate of speed and did not stop for the stop sign. I was traveling South on Armenia and had to come to a complete stop before she stopped quickly passed the stop sign in the roadway. She accelerated rapidly and made a wide right turn and was driving on the left side of the roadway. I conducted a traffic stop and made contact with the defendant who was the driver and only occupant of the vehicle. Upon contact I could smell the odor of alcoholic beverages from her breath. Her eyes were glassy and bloodshot. She was slurring some of her words as she spoke. She changed her story about what time she worked and how much she drank. She admitted to drinking 2 drinks. She performed field sobriety exercises and showed impairment. Post arrest I advised her of implied consent and she understood and refused to provide a breath sample.
