The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 08/30/20 at approximately 0153 I made contact with the defendant subsequent to a traffic stop at the intersection of Temple Terrace Hwy and E Riverchase drive for driving without headlights. I observed the defendant in the driver's seat of the vehicle and upon making contact I noticed her eyes were bloodshot and watery, and there was a moderate odor of alcohol emanating off her breath. Defendant agreed to perform field sobriety exercises in which she did not successfully complete. Defendant was asked if she would be willing to provide a sample of her breath to which she replied "yes". Upon completing a breath analysis at central breath testing, defendant had a reading of 0.048 and 0.047. Due to the impairment I observed on the roadside which was not consistent with the breath results, a urine sample was also collected for analysis.
