The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On 01/15/2021, at approximately 0307 hours, Deputy M. Archambeau was conducting traffic enforcement on Bloomingdale Av. He observed a 2018 silver Chevy Malibu bearing FI tag 460LI (VIN:1G1ZD5ST2JF179620) traveling west at a high rate of speed. Deputy Archambeau observed the vehicle traveling in the number 1 lane as he followed in the number 2 lane on westbound Bloomingdale Av. Deputy Archambeau paced the vehicle at approximately 55mph in a posted 45 mph zone. While pacing the Malibu, the vehicle began to drift into Deputy Archambeau's lane forcing him to make an evasive maneuver to avoid a collision. Based on the above, Deputy Archambeau conducted a traffic stop at the intersection of Bloomingdale Av / Gornto Lake Rd S and observed the defendant operating the vehicle. While speaking with the defendant, Deputy Archambeau detected signs of impairment. Affiant responded to the scene, detected signs of impairment, and requested the defendant perform field sobriety exercises which the defendant agreed to perform. During the exercises, the defendant showed signs of impairment and was subsequently arrested. After a proper 20 minute observation, the defendant provided a lawful breath sample that resulted in a BrAC of .147/.149. The defendant was identified via FL DL.
