Jason left the home in his Black Ford Expedition and possibly went to his parent's home in Osceola woods in Jupiter. Upon arrival to the area, a canvas was conducted to make sure Jason was not in the area. I then made contact with Jessica and she provided me with a sworn video-recorded statement of the following. Note the following statement is a summary and not purported to be verbatim.

Jessica was sleeping in her bed when Jason forcefully began shaking her awake, and screaming at her. Jason was upset over messages he had seen on her phone. The messages were between Jessica and another man. Jessica demanded that Jason give her phone back so she could call police. He complied but stated 'if you call the police ill kill Avery, you, and then myself.' Jason then lightly choked Jessica but not enough to cause a mark. It should be noted that W/F Avery Frein (09/90/2013) is the daughter of both Jason and Jessica.

Jason also lightly hit Jessica in the right breast causing a small red abrasion and prior to leaving he broke a glass picture frame. Jason had also grabbed Jessica's wrists causing small abrasions on both wrists. While this was occurring, their daughter Avery was sleeping in the living room on the couch and partially witnessed the incident. I took photos of all of Jessica's injuries she pointed out to me and later uploaded them to evidence.com

I asked Jessica if I could speak to Avery and she stated I could but Avery might be scared. Jessica insisted she be in the same room with Avery but said she would not talk to her. I spoke with Avery and it was evident to me that she was not telling me the true story of what happened. Avery was nervous and often looked towards her mother for certain answers, specifically when I asked if she heard her father loudly shout that he would kill Avery, Jessica, and himself. Avery stated she only heard Jason state he would kill himself.

Avery began looking nervous as I continued to talk to her, she kept pausing and making eye contact with her mother and holding a couch cushion when I was speaking to her. I then asked Avery if her father hit her mom, she said no, I then asked if her father touched her mother and if mom was scared, she said yes and she said that her dad was not hitting her mom hard. Based on the behavior Jessica was describing and Jason's described irate state, it did not seem to me that her injuries matched her allegations. I then left Jessica's home; at this point other units were looking for Jason.

Other units advised me over police radio that Jason was located and detained in the Osceola woods community. I responded to the area to get Jason's side of the story. Upon my arrival Ofc. Ferguson ID:385 advised me that he had read Jason his Miranda Warnings. I then took a sworn video-recorded statement from Jason. The following statement is a summary and not purported to be verbatim.

Jason stated that he and Jessica have a child sharing agreement and part of the agreement-included times they are to watch the kids, no illicit drugs in the house, and they are not to disseminate personal information about each other to third parties. At around 2130hrs Jason was home watching Avery so Jessica could go out with friends and her new boyfriend, however she was already supposed to be home to watch the kids so Jason could have his own personal time.

Jessica came home heavily intoxicated and Jason did not feel comfortable leaving her in custody of the kids so he stayed home. They began talking and Jessica wanted to go out and get Cocaine. Jason objected and told her he would go and get the Cocaine for her.

Jason got the Cocaine. Jason began audio recording his conversation now with Jessica. The recording was documented via BWC and later uploaded to evidence.com. In the recording you can clearly hear that Jessica is slurring her words and possibly intoxicated and talking about the Cocaine that Jason brought her.

Jessica did the Cocaine and after a while began arguing with Jason. Jason did not want it to escalate and began gathering a few things so he could leave. At this point Jason was in the bedroom with Jessica and she was on the bed. Jason noticed Jessica's phone and saw that she had been talking about Jason with her new boyfriend and disseminating personal details over text. This upset Jason and violated the agreement they had. He confronted Jessica. Jessica got defensive and threatened to call the police. Jason grabbed Jessica's phone and stated not to waist the police times and tried to talk to her about the messages. Jessica got mad and demanded the phone back. Jason complied and continued to try and leave.

Jessica made threats to get Jason thrown into jail. At some point Jessica took a picture frame and through it at Jason. Jason put his hands up and gut cut from the glass as the frame broke against his hands. Jessica then punched Jason in the right temple causing abrasions. Jason pushed Jessica away and left the home. Jason's injuries were documented and later uploaded to evidence.com

Jason then showed me text messages of Jessica stating to him that Avery would 'due right by her' and she would lie to the police and say he was suicidal. Ofc.Ferguson took photos of the messages and later uploaded them to Evidence.com.

I specifically took note of a text message time stamped at 0153hrs, which was sent from Jessica to Jason which stated the following "You call cops or him I tell them that you said you want to kill your children and then me and then yourself tonight"

Based on the above investigation, statements from all parties involved, physical evidence, and digital evidence, I find probable cause to arrest Jessica Irwin for the following:

- Aggravated Battery with a Deadly Weapon (Domestic) per Florida State Statute 784.045(1) (A) (2)
- Fraud - provide false report to police per Florida State Statute 817.49

Other Jupiter units took Jessica into custody and transported her to the Jupiter Police Department for processing. Jessica was later turned over to the Palm Beach County Jail.
