The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On 03/28/2021, at approximately 0440 hours, Deputy M. Trujillo (ABN 258678) was on proactive patrol when he observed a black Cadillac SRX, bearing Florida tag B6FXW, at the intersection of N Dale Mabry Hwy and W Fletcher Ave. Deputy Trujillo observed his vehicle to be stopped in the left northbound through lane of N Dale Mabry Hwy, which had a solid green traffic signal. Deputy Trujillo made consensual contact with the defendant, who was passed out behind the steering wheel. The vehicle's engine was running, the gear selector was in drive and the defendant's foot was on the brake pedal. Deputy Trujillo was able to wake up the defendant. Upon contact with the defendant, she had bloodshot glassy eyes, slurred speech and the distinct odor of an alcoholic beverage was emitting from her breath as she spoke. There was vomit on the defendant's clothing and down the inside of the driver's door. The defendant was asked to participate in the Standardized Field Sobriety Exercises, which she agreed. During the exercises, the defendant showed signs of impairment and was placed under arrest for DUI. The defendant then agreed to provide a lawful sample of her breath, which resulted in a BrAC of .153/.145. The defendant was positively identified via her Florida driver's license.
