The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 07/16/2021, the defendant and victim were involved in a verbal argument over the defendant having another female at their house. The victim came down stairs in fear that the victim was going to damage his vehicle due to past incidents. When he got downstairs, the defendant intentionally struck him in the face with a closed fist several times causing a laceration to his upper lip. While trying to defend himself, the defendant was struck in the left cheek causing no visible injury. She fell and scraped her left elbow suffering a small scratch. The defendant also bit his left his left shoulder causing bite marks and a slight laceration. The victim also suffered scratch marks on his right arm during the incident. The defendant was determined to be the primary aggressor. The defendant and victim have lived together as a family unit on and off for two years. They have one child in common. The victim positively identified the defendant as the person who committed this crime. Both parties were positively identified via RMS.
