Before me this date personally appeared COBBAN SEAN (3271) who being first duly sworn deposes and says that on 12 day of May, (year) 2017 at 6816 NW 32ND CT, MARGATE, FL 33063 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

her as he ran down stairs to leave the residence. At the front door, the defendant caught up to the victim and struck him several more times in the back of the head to where the defendant's own mother had to pull her off of him. The defendant then left the area. The above actions by the defendant were willful and intentional and against the will of the victim.

When we originally arrived on scene the victim was gone, but the defendant began to argue with her mother. While speaking to the defendant in her bedroom about the issue of why we were there, she stated she scratched at the victim's face and pushed him because he broke up with her and she wanted a cell phone back that she had purchased for the victim some time ago.

The defendant's mother, [REDACTED] also told me she witnessed the incident of her daughter hitting the victim by the front door and that she did have to separate them.

The victim arrived back on scene a short time later and advised me of the above incident. I did not observe any injury to the victim's face. The victim declined to give a taped statement or be photographed. The victim also declined all paper work we were to give him under domestic violence arrests.

The mother and father of the defendant declined to give a statement. Based upon the victim's allegations, the defendant's own admission, and the defendant's own mother's statement, I arrested the above defendant for Domestic Violence Simple Battery.
