Garcia (ABN:249274) contacted the driver on a traffic stop for headlights not in use. Upon contact with the defendant, the affiant detected the strong odor of an alcoholic beverage emanating from the defendant's breath, observed her eyes to be red/bloodshot and watery, fumbling fingers, and her to have unsteady balance. The affiant requested the defendant to perform Standard Field Sobriety Exercises (SFSEs), which the defendant agreed to do. During the SFSEs, the defendant showed multiple signs of impairment and was subsequently arrested for DUI.
