After running the vehicle's NH Tag, I observed the tag to be expired on 04/08/2020. During a traffic stop for the registration infraction, the defendant was identified via a NH DL and exhibited several clues of impairment, to include: Watery/Bloodshot eyes, blank/dazed stare, droopy eyelids, slurred speech, confusion with her paperwork, repeated the same questions several times in a row, emitted a distinct odor of an alcoholic beverage from her breath, and stated that she had nothing to drink at all. The defendant was arrested for DUI following a poor performance on SFSEs.
