PERSONAL CONTACT

DRIVING PATTERN: (Actual Physical Control; Physical Evidence or Statements Putting Defendant Behind Wheel of Vehicle)

On 05/30/2021 at approximately 0254 hours, This Officer was on patrol, in the area of 10000 block of Alt A1A, PBG, FL, when a vehicle was observed traveling at an increased rate of speed south bound in the inside through lane. Body worn camera and in car video were activated upon traffic stop. This Officer's initial visual estimation of the vehicle, was approximately 60 MPH in a posted 45 MPH zone. Using RADAR Stalker DSR2X (DB001317), forward antenna (KC086606) this Officer received a steady tone and reading of 63 MPH. The RADAR calibration was last checked on 05/27/2021 and was due on 11/27/2021. Prior to this tour of duty on this date, this Officer ensured the RADAR was in working order, to confirm the accuracy of the unit. At the end of this tour of duty, this Officer did the same. This Officer received RADAR/LIDAR certification on 05/31/2008, in Cannon AFB, NM. This Officer entered the same lane behind the vehicle and initiated a traffic stop on the vehicle, a Toyota sedan (KEXA32/FL) on Alt A1A just south of Lighthouse Dr, PBG, FL. This Officer made contact with the driver identified via Florida Driver License photo, Jillian Digiantomasso (OW), while she was still in the driver seat.

OBSERVATION OF DRIVER:

Digiantomasso had bloodshot watery eyes, was slightly sweating, slurred speech and the obvious odor of an unknown alcoholic beverage emanating from her breath at conversational distance. The odor increased in intensity as Digiantomasso spoke and the investigation carried on.

DRIVER STATEMENTS:

Digiantomasso said she was coming from a friend's house in Tequesta then going to the same house in Tequesta. Digiantomasso's passenger then said they were going to another friend's house. When asked how much she has had to drink tonight, she said "not much".

Other Observations:

Digiantomasso had vertical gaze Nystagmus in both eyes. Digiantomasso had to be reminded to properly follow the stimulus.

Walk and Turn

During the instructions, Digiantomasso stepped out of the starting position and had to be told to resume the proper position. During the first set of steps, Digiantomasso missed heel-to-toe on multiple steps. At one point, Digiantomasso stumbled and stepped next to the line. During the turnaround, Digiantomasso pivoted on both feet rather than as instructed. During the return set of steps, Digiantomasso missed heel-to-toe again multiple times and again took eight steps.

One Leg Stand

During the exercise, Digiantomasso raised her left foot. Digiantomasso swayed throughout the exercise and placed her foot down prior to being told to do so. Also, Digiantomasso was at times, not looking down at her raised foot.

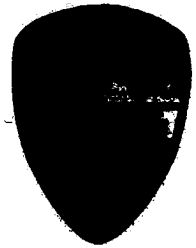

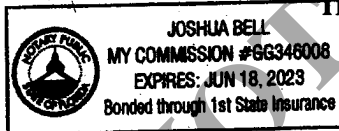
