I responded to assist DS Machin #35654 with a crash involving a possible impaired driver. Upon my arrival he advised me:

At approximately 2304 hrs, I was called to the scene of a traffic collision with property damage at 5890 Las Colinas Circle, in unincorporated Lake Worth, Palm Beach County, Florida, 33463.

VEHICLE 1 WAS SOUTH BOUND ON LAS COLINAS CIRCLE APPROACHING 5890 LAS COLINAS CIRCLE, UNINCORPORATED LAKE WORTH, FL, 33463. Witness, Scott Gibbons, identified the defendant, Jimmy Chapman, to me as the driver / sole occupant, of the defendant's vehicle at the time of the collision. (See the signed sworn written witness statement for more detail)

There were several witnesses to the crash as well as a video recording. The witnesses completed sworn statements. The statements and video were later submitted into the PBSD evidence custodian.

I also spoke to the defendant's wife, Jeanne Chapman, who stated she was not the driver and was not in the vehicle at the time of the crash. She stated she was out looking for him because he did not come home after the club closed.

OBSERVATION OF DRIVER:

The defendant had an obvious odor of an unknown alcoholic beverage on their breath. This odor intensified when the defendant spoke. The defendant's eyes were red and glassy. His speech was slurred and thick. He was swaying while standing. He had an unsteady gait as he walked to the front of my vehicle from his.

DRIVER'S STATEMENTS:

I advised the defendant the crash investigation concluded and I was now conducting a criminal investigation. I read him the Miranda Warnings which he stated he understood. He stated he was not driving and his wife was driving. He did not know where his wife was. He stated he was sitting in the front passenger seat at the time of the crash. He did not know how the crash occurred. He stated he drank 3 Vodka/Club Soda at Winston Trails between 9-11pm. He stated the current time was 10:30-11p, it was actually 11:47pm. He denied any injury, significant medical condition, or physical abnormalities.

ODORS:

The defendant had an obvious odor of an unknown alcoholic beverage on their breath. This odor intensified when the defendant spoke.

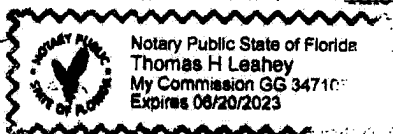

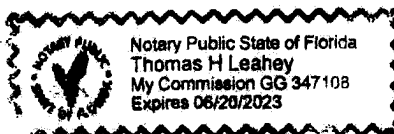

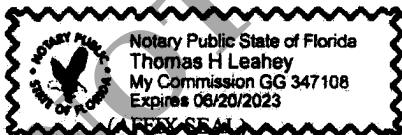
