The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 12/25/2020 at approximately 2031 hours, the defendant was involved in a rear-end collision with another vehicle on the roadway at the intersection of Riverview Dr and 41 Hw S. The defendant failed stop for the vehicle stopped at a steady red light and collided with the back of the victims vehicle then continuing through the intersection striking the second victims vehicle. The approximate amount of property damage was \$40,000. The defendant displayed several indicators of impairment throughout the crash investigation. I advised the defendant of my observations and asked the defendant to complete SFSE's. During the completion of SFSE's the defendant displayed several more indicators of impairment. I transported the defendant to CBT where she provided 2 breath samples of 0.190/0.178 BrAC after a 20 minute observation period. I issued the defendant DUI citation A71TVCE and a UTC for failing to yield to vehicle at intersection. The defendant identified herself verbally which was confirmed via DAVID. The defendant also had her 1 yr old son in the vehicle at the time of the offense.
