THE DEFENDANT WAS OBSERVED OPERATING HER MOTOR VEHICLE IN WHICH SHE PROCEEDED TO CHANGE LANES WITHOUT SIGNALLING AND CUTTING OFF ANOTHER VEHICLE WHILE CAUSING THAT VEHICLE TO BRAKE IN ORDER TO AVOID A COLLISION. UPON ATTEMPTING TO CONDUCT THE TRAFFIC STOP THE DEFENDANT CONTINUED DRIVING EAST BOUND AND SWERVING AND DRIFTING IN AND OUT OF HER LANE BEFORE EVENTUALLY PULLING OVER. UPON MAKING CONTACT WITH THE DEFENDANT I OBSERVED SEVERAL SIGNS OF IMPAIRMENT TO INCLUDE THAT HER EYES WERE BLOOD SHOT, WATERY, AND GLOSSY. SHE WAS VERY EMOTIONALLY AND WOULD NOT FOCUS. SHE PROVIDED ME HER CREDIT CARD AS HER DRIVER'S LICENSE. WHILE STANDING SHE WOULD STAGGER AND SWAY. SHE CONSENTED TO SFE'S IN WHICH SHE DISPLAYED SEVERAL MORE SIGNS OF IMPAIRMENT AND WAS UNABLE TO SATISFACTORILY COMPLETE THE SFE'S AND WAS PLACED INTO CUSTODY FOR DUI. THE DEFENDANT WAS FOUND TO BE IN POSSESSION OF DEXTROAMPHETAMINE, CLONAZEPAM, AND ALPRAZOLAM (TWO OF WHICH SHE IS NOT LAWFULLY PRESCRIBED). THE DEFENDANT DID PROVIDE A BREATH SAMPLE WITH THE RESULTS OF A .000/.000. THE DEFENDANT WAS PROVIDED MORE THAN AN HOUR WITH SEVERAL GLASSES OF WATER & NUMEROUS OPPORTUNITIES TO PROVIDE A URINE SAMPLE, HOWEVER, AFTER HAVING BEEN READ IMPLIED CONSENT, THE DEF WOULD NOT PROVIDE A SAMPLE.

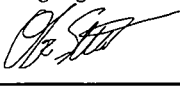

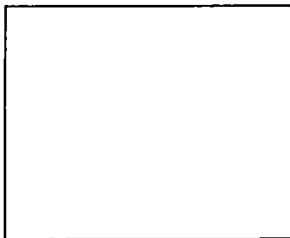
