On the above-listed date and time, Deputy R. McDermott #257240 observed a white Chevrolet Tahoe, bearing FL tag LANU65 (VIN: 1GNSKPKD3MR105085) stationary but running on the outside (left) lane of Gunn Hw. Deputy McDermott made contact with the driver, defendant and sole-occupant, and detected signs of impairment on the defendant. The affiant responded to the incident location and made contact with the defendant. The affiant observed the defendant had vomited on the side of his vehicle, had bloodshot watery eyes, and had the distinct odor of an alcoholic beverage emitting from his breath. The affiant requested the defendant perform Standard Field Sobriety Exercises (SFSEs), to which he agreed. During the SFSEs, the defendant showed multiple signs of impairment and was subsequently arrested for DUI. Once at Central Breath Testing, the defendant refused to provide a lawful breath sample after Implied Consent was read and understood. The defendant was issued DUI citation A851CDE, which reflects the charge. The defendant was identified via his FL DL.
