The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On the above listed date and time, at the listed location, the defendant and victim engaged in a verbal altercation after the defendant returned home intoxicated from a pool party. The altercation turned physical when the defendant shoved the victim against his will on an unknown part of his body and then threw a full large water bottle at the victim. The water bottle struck the victim above the right eye, causing a small contusion and red superficial laceration. The victim refused medical treatment. The defendant and victim are in a dating relationship and have lived together as a family for approximately 6 years. During the initial interview, the defendant admitted to the offense.
