The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On the above listed date, time, and location the affiant responded as a back-up officer on a traffic stop conducted on a wrong way driver. The initial officer had observed a black VW coupe bearing Florida tag NQWT85 driving northbound in southbound lanes and causing other vehicles to swerve out of the way to avoid a crash. Upon the affiant making contact with the defendant, the affiant observed her eyes were watery and bloodshot and had the smell of an alcoholic beverage emitting from her breath. The defendant had slurred speech and did not realize she had been driving the wrong way, though she stated she lived in the area and was familiar with it. The affiant then asked the defendant if she was willing to participate in standardized field sobriety exercises which she completed unsatisfactorily.

Based on the totality of the investigation, the defendant was placed under arrest for DUI. The defendant was transported to Central Breath Testing at Orient Road Jail where the affiant asked the defendant to submit to a chemical breath test. The defendant refused to submit to the breath test after being read implied consent. The defendant had a prior refusal to submit to testing on 06/12/1995. The defendant identified herself verbally and was confirmed by the affiant via DAVID.
