**NARRATIVE:** (Specifically include facts constituting cause for arrest).

On June 26, 2021 I began an Aggravated Stalking investigation at 6756 Third Street, Jupiter FL, 33458.

I spoke with Jacqueline Goldman (victim) and she told me that she has been going through a bad divorce with her husband, Joel Goldman (suspect) which resolved in February 2021, but she is still having issues with him. On 05/25/2020, Mr. Goldman was arrested in Broward County for Felony Battery by Strangulation against Ms. Goldman, which was part of the reason they got divorced. Currently Ms. Goldman is fighting for full custody of their two children after Mr. Goldman got their 15-year-old daughter drunk at Blondies. He was charged with contributing to the delinquency of a minor in Broward County 05/06/21 under case number 2103-043145. During the incident, he got mad and yelled at his daughter after she refused to answer more questions about her mother and her new boyfriend. In addition, complications of the COVID 19 restrictions, and Mr. Goldman not paying the business bills, taxes, and mortgage caused their wedding business to close. This has led to more conflicts about money and the dissolution of the business. She had received multiple messages and communications where Mr. Goldman wishes ill on her and for her to die painfully of cancer.

Mr. Goldman is a resident in Light House Point, and has never lived in Ms. Goldman's current

home. He has no reason to be at her home unannounced, and has only been there one other time to exercise his visitation rights with his children. Prior to June 26 Ms. Goldman was out of the country for her parents funeral. In that time Mr. Goldman was seen by the dog sitter at the house walking around the property twice. The second time she took pictures of Mr. Goldman in the driveway and sent them to Ms. Goldman. Ms. Goldman recognized Mr. Goldman as the man in the pictures. These pictures were submitted as evidence. June 26th was the day Ms. Goldman flew back into the state. When she got home she had her boyfriend look under the car for a tracker. She suspected that there would be a tracker because Mr. Goldman had made threats in the past to put one on her car as well as her previous boyfriend's car. When they looked under the car they found a black magnetic box stuck to the rear axle. Inside the black box there was a spy spot brand tracker and battery pack. A subpoena has been served requesting the account holder's information for this device. When the information was returned it showed that the name on the account was Jay Weingarten (other), the emails associated with the account are feetfixer@prodigy.net and feetfixdr@gmail.com. I served subpoenas to both companies that host these emails. The Gmail account was also registered to Jay Weingarten, the account was created and only accessed three times on June 26<sup>th</sup>, 2021, and the IP address associated with this account is 2601:589:4900:59f:9900:e0e9:9633:60d3, and the recovery email associated with this account is jmflowers954@gmail.com. Ms. Goldman has received multiple emails from this account calling her foul names and descriptions of how the sender wishes she would die. These emails are from, and were signed by Joel Goldman. On 08/03/2021 I received a picture of the original receipt for the purchase of the GPS tracker from Spy Spot Investigations. The purchase was made on 06/25/2021 at 125 East Hillsboro Blvd. Deerfield Beach FL, 33441 and the Master Card used belongs to Joel Goldman and ends in 3988.

Ms. Goldman was in a relationship with Mr. Weingarten as her marriage went through the final steps of her divorce. This enraged Mr. Goldman, and he began to harass Mr. Weingarten at work and through various electronic means. Ms. Goldman said that she hasn't had any negative interactions with Mr. Weingarten since their relationship ended. She said that he has no reason to put a tracker on her car they have both moved on from this relationship and are currently involved with other people. The harassment Mr. Weingarten received from Mr. Goldman was so extreme; he petitioned the courts for a restraining order.

On August 4, 2021 I spoke with Mr. Weingarten and he told me that he became involved with Mr. Goldman when he began dating Ms. Goldman. At the time their relationship began he had already been served divorce papers but was refusing to sign them. Mr. Goldman began harassing Mr. Weingarten over the phone, via email, showing up at his office, and reaching out to his extended family members. Even though Mr. Weingarten's relations ended with Ms. Goldman approximately four months ago Mr. Goldman still calls him weekly demanding to meet him and talk to him. On August 2, 2021 Mr. Goldman showed up at his office and left a threatening letter for him with his staff because he was out of the office. Mr. Weingarten told me that the emails that he uses are jupietjay@comcast.net, and feetfx@prodigy.net, he does not use any of the emails that are associated with the tracker. On June 25, 2021 Mr. Weingarten was working in his Stuart office with patients in the office and at a nursing home when the GPS tracker was purchased. On June 26<sup>th</sup> Mr. Weingarten was shopping for granite for his home remodeling project beginning at approximately 0825 hours near Riviera Beach, and he continued shopping at various places ending in Boynton Beach at approximately 1400 hours. Mr. Weingarten vehemently denies knowing anything about the tracker on Ms. Goldman's car. He did not purchase the tracker, place it on her car or create any accounts to monitor it.

At approximately 07:18 PM, July 19, 2021, I received the mobile device records from Verizon Wireless regarding mobile device number 561-829-7503. An analysis of the geolocation data and additional documents illustrated the following. The subscriber information highlighted mobile device number 561-829-7503 was registered to Joel Goldman of J. Morgan Flowers INC, 1500 West Copans Road, Pompano Beach, Florida,

33064. Per the historical cellular site location information, whenever there is activity on the mobile device associated with Goldman on June 26, 2021, beginning 11:36:04 AM continuing through 12:11:46 PM, the mobile device is facilitating transmissions through cellular sites and sectors having estimated handoff coverage areas encompassing his residence, 3700 North 22<sup>nd</sup> Avenue #5, Lighthouse Point, Florida, 33064. This evidence is consistent with the mobile device being at or in the geographical area of Goldman's residence. Continued analysis of the geolocation data highlights on June 26, 2021 beginning at 12:33:57 PM continuing through 02:02 PM, the historical cellular site location information highlights the mobile has traveled north from the geographical area of Lighthouse Point to the geographical area of Palm Beach Gardens, Florida. Detectives further analyzed the geolocation data and learned on June 26, 2021, beginning at 02:06:53 PM, continuing through 02:20:38 PM; the mobile device is facilitating transmissions through the same cellular sites and sectors having estimated handoff coverage areas encompassing the victim's residence, 6756 3<sup>rd</sup> Street, Jupiter, Florida, 33458. Furthermore, the geolocation data corroborates the cellular phone image the neighbor provided of Goldman capturing him in the victim's driveway at 02:20 PM, June 26, 2021. This evidence is consistent with Goldman's mobile device being at or in the geographical area of the victim's residence. At 03:08:11 PM, June 26, 2021, the historical cellular site location information highlights the mobile device associated with Goldman has traveled south from Jupiter, Florida, and is facilitating transmissions through cellular sites and sectors in Boca Raton, Florida. The call detail records further illustrates on June 26, 2021 to July 02, 2021, the mobile device associated with Goldman placed multiple blocked calls to the mobile device associated with the victim.

The receipt for the tracker purchase was dated/time stamped June 25, 2021, 1541.21 hours. Per the geolocation data, on June 25, 2021, between 15:22 hours through 16:00 hours, any network activity reflects the mobile device associated with Goldman is communicating with the same cellular site and sectors having estimated handoff coverage areas encompassing the location where the tracker was purchased. This evidence is consistent with the mobile device being at the store or in that specific geographic area.

Through the investigation, your affiant learned the morning of August 02, 2021, Ms. Goldman received an extremely disturbing voicemail and email from an account associated Joel Goldman. The following is a verbatim account of the email and voicemail:

Mr. Goldman sent a voicemail at 06:22 AM, August 02, 2021, where he called Ms. Goldman a "FUCKING BITCH AND GAS LIGHTER CUNT". He vehemently expressed how he was coming for her in court for taking his children away. He further expressed how she "FUCKED HIM OVER" by taking his children away and he was coming for Mr. Weingarten.

The following email was sent on August 02, 2021 at 06:52 AM:

"Jack (Gaslighting whore cunt), You have done nothing but alienate me from my children. In your sick mind do you really think you can get away with this? Your credibility is shit in the court system. You have already proven yourself to be a pathological liar in the court system. Do you really think you are going to get away with this? Wait until I get shold of you new boyfriend. Or did he already find out who you really are. Well, he came to the door to cover up for you last Friday night. Apparently he wants to get involved too. I ask Hashem to kill you slowly and painfully everyday. I hope the cancer eats you to the bone.

And I'm sure you blame me for the cancer. If I could have given it to you, I would have. I hope you die slowly and with a lot of pain. You fucked up everyone and everything in your path. And for what you did to those kids to serve your own self interest, is a crime in itself. Why don't you end your life now and give those half a chance at having a decent life. You are going to orphan them anyway. So do it quickly. No one will miss you. You destroyed everything you have ever touched. Your a

fuck up.. And that's all you will ever be. You tried to kill me and failed. You tried to have me put in jail numerous times and failed.

Do you really think you can yell out a crime and they will automatically throw me in the cell and throw away the key? You truly are fucking stupid? I hope your cunt lawyer Gina takes you for every dime you have. Maybe you figured out at this point Hashem is watching over me?"

Die fast, die painfully,  
Joel I. Goldman

The email on August 02, 2021, is consistent with harassing and disturbing sms messages Ms. Goldman received on July 01, 2021 from a fictitious google number the investigation established was associated with Mr. Goldman. The following is verbatim account of the messages from July 01, 2021:

"I am happy that both your parents died in the last 1 year. They should have died long ago as a punishment to breed a bitch like you. I hope your bastard children die in the next 1 year.

After a call attempt by Ms. Goldman, "Don't call me. I don't talk to road side prostitutes like you.

Nothing to gain by talking to sluts, are you raising your daughters to be whores like you too? If they are of a legal age to fuck, you can send them to suck my dick. Your pimp Marc tried to call me as well, bloody assholes."

Mr. Goldman sent an additional voicemail at 06:22 AM, August 02, 2021, where he called Ms. Goldman a "FUCKING BITCH AND GAS LIGHTER CUNT". He vehemently expressed how he was coming for her in court for taking his children away. He expresses how she "FUCKED HIM OVER" by taking his children away and he was coming for Mr. Weingarten.

Based on the data from multiple search warrants and subpoenas for cell phone numbers and account holder information there is a clear connection between the GPS tracker and associated accounts to Joel Goldman.

I find probable cause for the arrest of Joel Goldman for Aggravated Stalking, Instillation of a Tracking Device, Harassing Telephone Calls, and Harassment by use of Personal ID. Information.

Joel Goldman did willfully, maliciously, and repeatedly follow, harass, or cyberstalk Jacqueline Goldman, and did make a credible threat as defined in Florida Statute 784.048(1)(c) to her, contrary to Florida Statute 784.048(3). (3 DEG FEL) (LEVEL 6)

Joel Goldman did knowingly install a tracking device or tracking application on the vehicle of Ms. Goldman without her consent, contrary to Florida Statute 934.425(2) and (5). (2 DEG MISD)

Joel Goldman did make a telephone call or telephone calls to Ms. Goldman at a place at which she had a reasonable expectation of privacy, and during such call or calls did make any comment, request, suggestion, or proposal which were obscene, lewd, lascivious, filthy, vulgar, or indecent, and by such call or language did intend to offend, annoy, abuse, threaten or harass any person at the called number, contrary to Florida Statute 365.16(1)(a). (2 DEG MISD)
