The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The victim and defendant currently live together as a family. The victim and defendant have three children in common and have been in a relationship for approximately fifteen (15) years. On this date, the victim and defendant engaged in a verbal altercation. During the altercation, the defendant grabbed the victim by the shoulders and pushed her against her will. During this incident, the defendant also grabbed the victim's right wrist and twisted her wrist causing pain. The defendant then removed her cellular phone from her pocket and fled the residence. The victim was not injured during this incident. The defendant later returned to the apartment making contact with law enforcement at which time denied any physical altercation took place between the parties. The defendant spontaneously advised he did grab the victim by the wrist and took the victim's cell phone away from her. The defendant was then read his Miranda rights, at which time he invoked his rights and refused to answer questions. The defendant was positively identified as the suspect while on scene by the victim.

The defendant was also identified via DAVID photograph.
