The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On the listed date and time, at Hillsborough Av W / Longboat Bl W within Hillsborough County, the affiant contacted the driver on a traffic stop for speeding. The affiant observed the defendant in the driver seat and sole occupant of the vehicle. Upon contact with the defendant, he emitted an odor of an alcoholic beverage from his breath, had bloodshot and watery eyes, and an unstable balance.
