The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:  
 On 08/29/2020, at approximately 0155 hours, I responded to 13220 301 Hw S. Riverview, Fl. 33579 to assist Deputy Crosby (ABN: 255027) with a suspicious person call for service. Call notes related the following, "7 ELEVEN....WM IN WHI CHEVY SILVERADO @HJBR68/ SEEMS TO BE VERY S/02 AND SITTING IFO THE STORE....WAS JUST IN THE STORE AND TOLD A EMPLOYEE HE IS S/02". Deputy Crosby explained to me that he observed the vehicle to be parked in the middle of the property o 7-Eleven and not in a parking spot. Deputy Crosby observed the defendant to be asleep behind the wheel. When the defendant woke up, Deputy Crosby observed indicators of impairment. When I made contact with the defendant, I observed him to have watery/glassy eyes, slurred speech, odor of an alcoholic beverage emitting from his breath, and was unsteady on his feet. The defendant elected to perform the standardized field sobriety exercises, and doing so, I observed more indicators of impairment. At Central Breath Testing, at Orient Road Jail, the defendant agreed to provide lawful breath samples after implied consent was read and after a twenty minute observation. The breath samples were recorded at .125 and .121. The defendant identified himself via Florida driver's license.

Pursuant to Florida Statute §92.525 and under penalties of perjury, I declare that I have read the foregoing document and the facts stated in it are true to the best of my knowledge. For Notices to Appear, I also certify that a complete list of witnesses and evidence known to me is attached.
