at approximately 9:20 PM, at GULF TO BAY BLVD AND PARK PLACE BLVD, in Pinellas County did:

DID, WHILE HAVING HIS DRIVING PRIVILEGE PREVIOUSLY SUSPENDED FOR A PRIOR REFUSAL TO SUBMIT TO A LAWFUL TEST OF HIS BREATH, URINE, OR BLOOD, REFUSE TO SUBMIT TO A CHEMICAL OR PHYSICAL TEST OF HIS BREATH, URINE, OR BLOOD AS DESCRIBED IN F.S.S. 316.1932 AFTER BEING REQUESTED TO DO SO BY A LAW ENFORCEMENT OFFICER, OR CORRECTIONAL OFFICER AND WHO THE ARRESTING OFFICER HAD PROBABLE CAUSE TO BELIEVE WAS DRIVING OR IN ACTUAL PHYSICAL CONTROL OF A MOTOR VEHICLE WHILE UNDER THE INFLUENCE OF ALCOHOLIC BEVERAGES, CHEMICAL SUBSTANCES OR LAWFULLY ARRESTED AND INFORMED THAT IF PRIVILEGE TO OPERATE A MOTOR VEHICLE WOULD BE SUSPENDED AND WAS INFORMED THAT A REFUSAL TO SUBMIT TO SUCH TESTS, IS A MISDEMEANOR.

THE DEF WAS OBSERVED IN ACTUAL PHYSICAL CONTROL HIS VEHICLE WHEN HE WAS OBSERVED BY OFFICER HURT TO BE TRAVELING EAST BOUND ON GULF TO BAY BLVD. AT AN ELEVATED RATE OF SPEED. OFFICER HURT WAS CONDUCTING A SEPARATE TRAFFIC STOP AND THE DEF FAILED TO MOVE OVER OR SLOW DOWN WHILE PASSING OFFICER HURT. OFFICER HURT WAS ABLE TO VISUALLY ESTIMATE THE SPEED OF THE VEHICLE TO BE 55 MPH IN A 40 MPH ZONE. OFFICER HURT THEN OBSERVED THE VEHICLE TO BE UNABLE TO MAINTAIN A SINGLE LANE AS IT DRIFTED INTO THE MIDDLE LANE. OFFICER HURT CONDUCTED A TRAFFIC STOP AND IMMEDIATELY OBSERVED SEVERAL SIGNS OF IMPAIRMENT TO INCLUDE BLOODSHOT WATERY/GLASSY EYES, SLURRED/MUMBLED SPEECH, SWAYING BACK AND FORTH, AND THE STRONG ODOR OF AN ALCOHOLIC BEVERAGE COMING FROM THE DEF BREATH. THE DEF ADVISED HE HAD SEVERAL ALCOHOLIC BEVERAGES PRIOR TO DRIVING. THE DEF PARTICIPATED IN SFST AND PERFORMED POORLY ON ALL SFST. THE DEF THE REFUSED TO PROVIDE A SAMPLE OF HIS BREATH.

THE DEF HAD PREVIOUSLY REFUSED TO PROVIDED A SAMPLE OF BREATH, URINE, OR BLOOD IN A SEPARATE PREVIOUS UNRELATED QUI INVESTIGATION.


ADVISORY AND SOLVENCY HEARING

I FURTHER CERTIFY THAT:

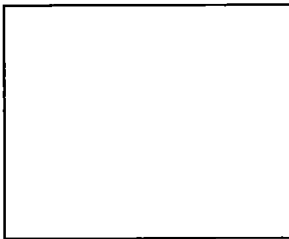
- A. Defendant has advised the Court that he has retained counsel or will retain counsel.
