The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On November 15, 2020 the defendant was operating his 2005 gold Toyota Camry bearing Florida license plate#: 098NLH (VIN: 4T1BE32KX5U047137) when the front of his vehicle struck the rear of a 2018 white Volkswagon Tiguan operated by victim Sharday Moore with victim Capri Madgett (victim). The collision caused approximately \$1000 in damages. The defendant attempted to flee the crash with witness Jeno Maturi and the victim following. The victims and witness were eventually able to block traffic and stop the defendant from traveling any further. Victim Moore and witness Maturi both positively identified the defendant as the driver of the vehicle. Deputy R. Gogolin ABN#: 5107 observed the defendant to have slurred speech, and to be unsteady on his feet. Deputy B. Shannon ABN#: 250551 observed the defendant to have bloodshot watery eyes, slurred speech, to be unsteady on his feet and he detected the odor of an alcoholic beverage emanating from the defendant's breath. I observed the defendant to have bloodshot watery eyes, to be unsteady on his feet, and I detected the odor of an alcoholic beverage emanating from the defendant's breath. The defendant refuse to perform standardized field sobriety exercises. Once at Central Breath Testing, after a twenty-minute observation period, the defendant provided lawful breath samples showing a breath alcohol concentration of .173/.179. I confirmed the defendant's identity via DAVID.
