The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 8/7/2021, at approximately 0039 hours, at 5600 Hoover Bl., Tampa, FL 33634, Deputy Kertesz (ABN 259142) conducted a traffic stop on a silver Ford F-150 (bearing FL tag BSEX14 / VIN: 1FTEW1CG5HKD14956) for operating without headlights/taillights from sunset to sunrise (FSS 316.217). Deputy Kertesz observed the defendant to have glassy, watery, bloodshot eyes, and slow, slurred speech. Upon asking for the defendant's vehicle documentation he fumbled and displayed disoriented behavior. Based on the observed indicators of impairment, Deputy Kertesz requested a DUI investigator respond to the scene. Upon my arrival, I observed the same indicators of impairment listed above, as well as observed the defendant struggle to exit his vehicle. I also observed the defendant struggle to maintain his balance and almost fall over, and I detected the odor of an alcoholic beverage. The defendant was given multiple opportunities to perform field sobriety exercises, which he refused. Subsequent to arrest, the defendant refused to submit to testing after being read implied consent. The defendant was identified via their Florida driver's license. The defendant was previously convicted of DUI on 07/08/2002 (Citation/Case #: 035923W) and has a previous refuse to submit breath/urine/blood test (Citation/Case #: 035923W).
