On Tuesday, January 12, 2021, at approximately 12:12a.m. I responded to 401 Club Drive, Palm Beach Gardens, Florida, in reference to a domestic disturbance. My department issued body-worn camera was used for the entire investigation.

Upon arrival Officer Lusavich (513) made contact with the caller Savannah Faulk who was upset and crying in the parking lot. I continued to the residence and made contact with the male half John Beasley. Beasley gave a statement via BWC stating the following; Earlier in the night, he and his girlfriend Savannah Faulk went to U-Tiki and Square Grouper in Jupiter, Florida for dinner and drinks. They both had a little too much to drink tonight and were starting to argue. Beasley stated when they got back to the house, Faulk got out of the car with his gun (Glock 19) and pointed it at his chest. Beasley then grabbed the gun from her, and Faulk ran to the front door with the key. After 30 seconds of Faulk trying to get into the house and then arguing, he grabbed her and threw her out of the way, so he could open the door. Once he got into the residence, he put his stuff down on the counter/chair and dragged her into the residence. Shortly after Faulk was on the phone with police. Beasley was very aggressive with officers throughout the entire investigation.

I made contact with Savannah Faulk who gave a statement via BWC stating the following; She went out for dinner and drinks with her boyfriend of 10 months, John Beasley to U-Tiki and Square Grouper in Jupiter, Florida. They were on their way home and started to get into an argument. Faulk was in the passenger seat and put it back to relax until they got the residence. When they got to the parking lot, Beasley's gun was near the center console. She picked it up and was asking him what he wanted to do with it due to it being out in the open. She said Beasley freaked out and grabbed the gun from her. She let it go and walked up to the front door to try and get into the house. While she was trying to open the door, Beasley came up behind her, grabbed her by the shoulders and threw her to the ground. When she was thrown to the ground, her Apple watch

She sat on the floor for a few minutes while on the phone with 911 before walking outside to get away from Beasley. Faulk advised at no time did she point a gun at Beasley, she grabbed the gun to give it to him to see what he wanted to do with it. Faulk advised when she fell, she hit her head and elbow on the ground. Faulk lifted the hair on the back of her head up and there was a red mark indicative of someone hitting their head on the ground. On her left elbow she had a small scrape similar to road rash from when her elbow hit the concrete. Faulk was also wearing black leather pants, she had white dirt all over the back of her pants from when she hit the concrete. Faulk denied medical attention.</p> <p>Based on my investigation and totality of the circumstances, there is probable cause that John Beasley was the primary aggressor and in violation of F.S.S. 784.03(1) - Simple Battery - Dating Violence. Beasley was transported to the county jail without incident.</p> <p>Faulk was given victim rights pamphlet, filled out a victim notification form, and was given the case number. There was a Ring doorbell on the front of the residence, we are attempting to obtain that footage, but at this time it is unavailable as this house is a rental property and we were unable to make contact with the owner.
