Road 91 (Florida Turnpike) around the approximate 116 mile marker in the inside/left hand travel lane. I observed a red Lexus SUV that was traveling northbound on State Road 91 in the outside/right hand travel lane just ahead of my patrol vehicle. I observed the vehicle traveling with the front left tire blown out. I observed the vehicle traveling on just the metal rim with no tire tread left on the front left side. I observed the vehicle all over the road and failure to maintain its single lane.

At that time, I conducted a traffic stop on the vehicle northbound on State Road 91 at the 117 mile marker off the right hand paved shoulder of the roadway. I made contact with the driver, who I identified later by his Florida drivers license (M-650-460-63-298-0) as Mr. John Marino. While making contact with Mr. Marino, he seemed dazed and confused. Mr. Marino had a hard time finding his license. I asked Mr. Marino to step out of the vehicle so I could observe him better. As I was speaking to Mr. Marino outside of the vehicle he would stumble around and would at times appear to lose his balance while walking. I asked Mr. Marino if he had taken any medications and or alcohol. Mr Marino stated that he had taken medication in the morning time. While I was continuing to make contact with Mr. Marino, he appeared to be under the influence or some type of narcotic and/or alcohol. Shortly after, Trooper Leslie, I.D #1460, arrived on scene to assist.

At this time, I asked Mr. Marino if he would be able to perform a series of Standard Field Sobriety Exercises (SFSE's), to which he understood and also complied. During the SFSE's, Mr. Marino performed poorly throughout the investigation. Mr. Marino was unable to follow some instructions properly and poorly performed the series of SFSE's that he was instructed to perform, which were the Horizontal Gaze Nystagmus (HGN) and Vertical Gaze Nystagmus (VGN), Walk and Turn, and One-Leg Stand. (Refer to In-Car Video and Incident report for further observation and information).

At the conclusion of my criminal investigation for DUI, I placed Mr. Marino under arrest for the suspicion of Driving Under the Influence of alcohol and or narcotics,

The first breath sample was 0.122 and the second breath sample was a 0.124.

Mr. Marino was finally processed and booked into the Palm Beach County Jail for DUI.
