The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 9/29/2020 at approximately 2259 hours, the defendant was stopped for a traffic infraction and failure to maintain his traffic lane by Cpl Phillips 97508. Upon Cpl Phillips contact with the defendant he observed several indicators of impairment including the defendant fumbling through his credit cards trying to find his DL. Upon my contact with the defendant, I noted bloodshot watery eyes and a strong odor of alcoholic beverage and the admission of consuming alcoholic beverages. During the completion of the SFSE's, the defendant displayed several more indicators of impairment. Once at CBT, the defendant refused to provide the lawfully requested breath samples after being read implied consent in CB-01. The defendant was issued DUI citation A49J8PE for DUI.
