

McMahan gave a sworn statement advising her and her husband John McMahan (DOB 12/31/1977) were at Cooper Hawks having dinner. M. McMahan stated her husband had several drinks at the restaurant and they began arguing. M. McMahan stated J. McMahan gets very aggressive when he drinks. M. McMahan advised she had to take an Uber home from the restaurant because J. McMahan left her at the restaurant. M. McMahan advised when she returned home at approximately 2100 hours, she and her son Aiden McMahan (DOB 8/20/2009) were playing cards in the living room. M. McMahan advised while she was playing cards with her son, J. McMahan picked her cell phone up from the couch in the living room and started going through her cell phone because J. McMahan believed she was having an affair. M. McMahan advised J. McMahan went to her maps in her cell phone and started pinging locations where she had been. M. McMahan stated she went to retrieve her phone from J. McMahan, and that is when he became aggressive and hit her on her forehead. M. McMahan advised she is unsure what hand J. McMahan hit her with. M. McMahan advised before the physical altercation; she was filing for divorce because it is an ongoing issue with J. McMahan getting violent when he drinks. Officers observed a little swelling above M. McMahan's right eye.</p> <p>I then made contact with M. McMahan's mother Rita Carroll (DOB 8/9/1950) who also lives at the residence. Carroll gave a sworn statement advising M. McMahan and J. McMahan were at dinner. Carroll stated J. McMahan left M. McMahan at the restaurant and she had to call an Uber to transport her home. Carroll advised when M. McMahan got home, she and Aiden were playing when J. McMahan began to go through M. McMahan cell phone. Carroll stated M. McMahan attempted to get her cell phone from J. aggressive and struck M. McMahan in the head. Carroll advised J. McMahan gets aggressive when he drinks.

I then made contact with the caller Aiden who stated J. McMahan was very aggressive. Aiden advised J. McMahan and M. McMahan were by the couch when J. McMahan hit M. McMahan in her head. Aiden stated J. McMahan walked away then walked back to the couch, grabbed M. McMahan and threw her on the couch.

At this point in time, I made contact with J. McMahan who was read his Miranda Warnings from a department issued pre-printed card by Officer Basinger ID 428. J McMahan refused to give a statement on what occurred. J. McMahan was then placed into custody and transported to Palm Beach Gardens Police Department for processing. I observed no bruising on M. McMahan's head. M. McMahan was given a Victims Rights Brochure and a Victim Notification Form.

Based on the facts and circumstances, to include statements from all parties involved, I found John McMahan to be the primary aggressor. There is probable cause to arrest J. McMahan for Battery (Domestic) F.S.S 784.03(1) (A) (1). J. McMahan was transported to Palm Beach County Jail without incident.
