The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 07/02/2021, at approximately 1832 hours at the intersection of 301 Hw S / and Symmes Rd, the defendant was involved in a vehicle crash. The defendant was observed by an independent wheel witness behind the wheel of a silver Ford F150 at the time of the crash. Deputy Berrios (ABN 252155) completed the traffic crash investigation (HCSO 21-438533) and estimated the total property damage at \$500. I made contact with the defendant and advised him I was conducting a separate criminal DUI investigation. I read the defendant his "Miranda Warnings" from an agency issued Warning of Constitutional Rights card. The defendant waived his rights. The defendant stated he left the Tiki Dock restaurant where he had two beers. The defendant emitted an odor of an alcoholic beverage from his breath, had slurred speech, and bloodshot watery eyes. I asked the defendant if he was willing to perform some Standardized Field Sobriety Exercises (SFSE). The defendant stated "No". I informed the defendant the SFSEs were voluntary however, his refusal could be held against him in a criminal proceeding, and I would have to base my investigation on the observations I've seen. The defendant still refused. Based on the totality of the investigation, the defendant was arrested for DUI with property damage. As I was attempting to place the defendant into handcuffs, the defendant tensed up, balled his hands into fists, and pulled away. The defendant continued to actively resist until more deputies arrived on scene. The defendant was placed into my patrol car without further incident. The defendant was transported to Central Breath Testing where he refused to provide a lawful breath sample. I advised the defendant of the Implied Consent warning in CB-01 room in CBT, where he still refused (see video). Subsequently, I completed the Affidavit Of Refusal To Submit To Breath Test. The defendant was positively identified via a Florida DL photograph.
