The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On February 20, 2020, Mr. John Docherty, was found advertising regulated construction services via flyer. Mr. Docherty agreed to provide an estimate for remodeling services at 10818 Highway 92. On February 21, 2020, Mr. Docherty met with the affiant, who was posing as the property owner, at which time he inspected the parking lot. After taking measurements Mr. Docherty advised he could use three tons of asphalt to repair the parking lot and seal coat and restripe the parking lot in exchange for \$4,500.00 in monetary compensation. Mr. Docherty, who is an unlicensed contractor, unlawfully contracted his construction services in exchange for a total of \$4,500.00. The Florida Department of Business and Professional Regulation and the Hillsborough County Building Department verified Mr. Docherty's non-licensure status. Additionally, the Hillsborough County Building Department confirmed the scope of work contracted by the defendant is regulated, requiring specific licensure as a contractor and the issuance of a building permit. The defendant was positively identified via his Florida driver's license, D263479961310.
