The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On 03/15/2021, at approximately 0359 hours, located in front of 9321 Cerulean Dr, Deputy Correa (ABN 257638) contacted the defendant on a person down call for service. Call notes stated a male was in the driver's seat of a Chevy Camaro unresponsive. Deputy Correa arrived on scene and observed the defendant behind the wheel of a blue Chevy Camaro bearing FL tag IGF8L. Deputy Correa knocked on the driver window several times until the defendant became responsive. The defendant emitted an odor of an alcoholic beverage from his breath, had slurred speech, bloodshot watery eyes, and he had unstable balance. Standardized Field Sobriety Exercises were conducted and impairment was observed. Based on the totality of the investigation, the defendant was arrested for DUI. Post Miranda the defendant admitted to drinking 5 rum and cokes. The defendant provided two lawful breath samples of .223 BAC and .232 BAC after a proper 20 minute observation was completed. The defendant was positively identified via a Florida DL photograph.
