On the 8 day of April, 2022 at 16:36 (Specifically include facts constituting cause for arrest.) On 04-08-2022, at 1524 hours, I responded to 5700 W Glades Rd, Boca Raton FL (Macys`) in reference to a shoplifting investigation. The suspect was being detained by Macys` loss prevention employee W/M Jared Reyes and W/F Lili Balian. I made contact with Balian and she stated she was watching the sales floor through CCTV when she noticed an unknown white female, later identified as W/F Joli Rumrill acting suspiciously. Rumrill was looking around at her surroundings which is a common practice for shoplifters. Due to Balian`s training and experience, she believed Rumrill was going to commit a crime. Balian stated Rumrill is seen on CCTV entering the second-floor entrance/exit of Macys at 1415 hours. Once inside Macys, Rumrill is seen selecting items off the sales floor at approximately 1416 hours on the second floor. Rumrill then enters a pre-swept fitting room on the second floor with the selected items. A few moments later she exits the fitting room leaving nothing behind. At that time, Macys` loss prevention Jared Reyes had walked onto the sales floor in anticipation that Rumrill was going to pass all points of sale with the concealed merchandise. At approximately 1516 hours, Rumrill is seen walking past multiple points of sale and failed to pay for the concealed merchandise and exited the store (south entrance). Reyes verbally identified himself as Macys` Loss Prevention and notified her that she was being detained for shoplifting. The merchandise was recovered from Rumrill`s Macys` shopping bag. Rumrill understood her rights and I questioned her about the incident. Rumrill stated that she walked into Macys' and stole several items. Rumrill further advised that she knew her actions were wrong and verbally confessed to the theft. While attempting to leave the store without the unpaid merchandise, she was stopped by Macys' Loss Prevention employee. Searched incident to arrest, a magnet was located inside her purse which is commonly used to defeat sensors. I asked Rumrill about the magnet and she stated she said it was for a science project and was not being forthcoming. Ultimately Rumrill stated she had brought that magnet incase she needed to take off any sensors from the items she planned to steal. Rumrill stated she had learned about that from online. I then advised Rumrill that she was under arrest for retail theft and the possession of anti-shoplifting device. Based on my investigation Rumrill was placed under arrest for Retail Theft per FSS 812.015 1(D) Possession of Anti-shoplifting device FSS 812.015(7). Balian supplied a printed receipt of the stolen items, I photographed the stolen items on my mvr, a written statement and a copy of the CCTV security footage. All of these items were placed into evidence. Rumrill was ultimately transported to Palm Beach County Jail for final deposition.
