


At the time, I was driving a Jupiter Police Department patrol vehicle (vehicle 1308), I was wearing a JPD uniform clearly identifying myself as a Jupiter Police Officer, and I was wearing my department-issued Axon body camera.</p> <p>While enroute, NorthCom advised the caller (Security Officer for Jupiter Harbour), Ian Darrah, stated a vehicle with the muffler hanging off had just driven through the gate without stopping to check in. The Security Officer advised the driver of the vehicle was a white male with short, dark hair. He also stated he did not believe the driver was a resident of the community and that the vehicle had not left the community. Security provided a possible tag starting with "DEW" being displayed on the vehicle.</p> <p>Officer Schneider (ID 330), the first officer on scene, located the vehicle: a blue Volkswagen sedan bearing FL tag # QEWO34. The vehicle was traveling southbound within the community. Officer Schneider advised via the police radio that he was conducting a traffic stop on the vehicle and that the vehicle was driving on the front driver side rim. See supplement from Officer Schneider.</p> <p>Upon arrival, I made contact with Officer Schneider, who provided me with the driver's Class E Florida driver license. I identified the license as belonging to Jon Pouso (w/m; 12/06/1973). Officer Schneider advised me he conducted a traffic stop due to the vehicle driving around on the front driver side rim, that he observed Pouso as the driver of the vehicle, and observed several indicators of impairment.</p> <p>I observed Pouso was standing outside the driver side of his vehicle. Pouso was leaning his back against the car. As I approached, I observed the front driver tire was completely gone and the rim was scraping against the asphalt. I observed two, parallel</p>



<p>scrapes behind the obliterated front tire which were obviously caused by the rim damaging the pavement.</p> <p>I made contact with Pouso and observed he had bloodshot, glassy eyes and a flushed face. Pouso spoke with heavily slurred speech. I could smell the faint odor of an unknown alcoholic beverage on Pouso's breath which intensified as he spoke. Pouso advised he works for Florida Power and Light and that he had "retired" for the evening. When asked to clarify what he meant, he explained that "retiring" is jargon used to describe the end of the work day. Pouso advised he got off work at midnight. It was approximately 2240 hours when I asked. Pouso advised he believed it was 6 or 7 currently. Pouso advised he works for an FPL substation in Manatee County, that he lives in Bradenton, and was unable to explain what he was doing in Jupiter other than that he was at work earlier. Pouso stated he did not have anything to eat but that he had drank "quite a bit". I asked if Pouso felt as though he was in any condition to drive his vehicle and he stated he believed he was.</p> <p>While I was speaking with Pouso, he appeared unsteady on his feet even though he was leaning against his car. At one point, Pouso grasped the B-pillar of the vehicle with his right hand through the open driver door window to steady himself.</p> <p>I requested Pouso complete Standardized Field Sobriety Tasks (SFSTs) to help me feel better about his condition to drive a vehicle and he refused. I briefly explained each of the SFSTs to him (Horizontal Gaze Nystagmus, Walk and Turn, One Leg Stand, Finger to Nose, and Romberg Alphabet) so he knew exactly what he would be refusing. After explaining the tasks, I advised him of his Taylor Warnings. Pouso advised he understood and ultimately refused to perform SFSTs.</p> <p>Based on the totality of the circumstances, I placed Pouso under arrest for DUI. I requested (at roadside) Pouso provide a lawful sample of his breath for the purpose of determining the alcohol content. Pouso refused. I read Pouso Implied Consent (including the recently-implemented BUI penalty verbiage but excluding the CDL portion of Implied Consent), confirmed he understood, and again requested he provide a breath sample. Pouso refused at 2253 hours.</p> <p>I transported Pouso to the Jupiter Police Department for the completion of the arrest paperwork and requested Pouso sign the DUI Citation, as required by law. Pouso advised he did not wish to sign despite my explanation to him that his signature is not an admission of guilt, only a promise to appear in court.</p> <p>Based on the aforementioned facts resulting from my investigation, I find Probable Cause exists to charge Jon Pouso with DUI - Normal Faculties Impaired pursuant to FSS 316.193(1)(a) and Refuse to Sign/Accept Citation pursuant to FSS 318.14(3).</p>
