The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 12/20/19, at approximately 2343 hours, affiant stopped defendant in his red Ford F250 (FL tag DQUY32) after observing it leave its travel lane multiple times and nearly striking another vehicle. The defendant was the sole occupant of the vehicle and was observed to have red watery eyes, slurred speech, fumbling fingers, and odor of alcoholic beverage on his breath. Defendant was unsteady on his feet and stumbled when exiting the vehicle. The defendant refused to perform field sobriety exercises at the scene after being explained the possible consequences. Defendant was arrested for DUI based upon the totality of the observations and provided breath samples of .135/.151 after 20 minute observation period. Defendant was identified via his Florida Driver License.
