The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 05/31/2021 at 2358 hours I conducted a traffic stop on a white 2015 Lexus sedan after I paced it at over 55 MPH in a posted 40 MPH zone and also observed it drifting out of its lane of travel as it traveled northbound on Howard Av N from Cass St W. Upon contact with the driver, defendant Jonathan Bonga, I observed that he had bloodshot glassy eyes and as I explained to him why I had stopped him I detected a distinct odor of an alcoholic beverage. When I asked her how much did he have to drink tonight he replied "nothing. I'm coming from work". The defendant then declined to perform the standardized field sobriety exercises. At which time I placed him under arrest for DUI based upon on all of my observations made thus far in my investigation. The time of arrest was 0004 hours. I then transported the defendant to the HCSO/CBT Facility where he refused to provide a breath sample. Implied Consent was read at 0035 hours. I identified the defendant with a FL DL.
