The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 The defendant, who was identified by his Florida driver's license, was passed-out behind the wheel of his car at a green light on Dale Mabry Hwy. N. (northbound lanes) at I-275. Defendant had glassy eyes, slurred speech and an odor of an alcoholic beverage emitting from his breath as he spoke. Defendant was unsteady on his feet and swayed back and forth and from side to side. Upon checking the defendant's eyes I observed 6 point nystagmus present. When I asked if the defendant would be willing to perform some additional SFST's he did not answer. Defendant was arrested for DUI and handcuffed. While retrieving the defendant's cell phone and wallet from his car, in plain view I observed a small plastic baggie which was in the center console next to the gear shifter. The baggie contained a white powder, which was field tested and showed a positive response for Cocaine. Once at CBT I read the defendant implied consent and he refused a breath test. These offenses occurred in Hillsborough County, Florida.
