The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
On the above listed date, time, and location I observed a black Volkswagen Jetta bearing TX #22233DV
(VIN:3VWDX7AJ3BM096121) traveling northbound on Dale Mabry Hw. at a high rate of speed. I visually estimated this
vehicle traveling at 85 MPH. I captured this vehicle with my issued laser at 90 MPH (1021.4 FT). I observed this vehicle
weave to the right exiting the center lane into the outside lane. I activated my emergency equipment to conduct a traffic stop
on this vehicle. I made contact with the defendant and observed signs of impairment to include bloodshot watery eyes, and
the odor of an alcoholic beverage emitting from his breath. The defendant informed me he consumed a couple of beers at
Scores Gentlemen's Club. The defendant was asked to participate in the Standardized Field Sobriety Exercises, which he
agreed. During the exercises the defendant showed signs of impairment. The defendant was subsequently arrested for DUI.
The defendant provided a breath sample after a 20 minute observation period the defendant provided two lawful breath
samples (BAC .168/.163). The defendant was identified via Florida driver license.
