On the above date and time I was dispatched to 1635 Renaissance Commons Blvd Boynton Beach, (Palm Beach County) FL 33426 in reference a disturbance.


BBPD Dispatch advised the caller heard a W/M later identified as W/M Goldstein, Jonathan state he was going to throw a dog of the balcony of the above address. BBPD Dispatch then advised they received an additional call from the Renaissance Commons Leasing Office stating a white male they identified as Goldstein a resident, was holding a dog over the balcony threatening to throw it off but believed the dog was choked to death already. A third call was then received 5 minutes later, they advised Goldstein was walking with the dog in his hands as if the dog was being choked towards Bonefish Grill at 1880 N Congress Ave Boynton Beach, FL 33426.


Upon arrival, I located Goldstein north of the AT&T store located at 1880 N Congress Ave Boynton Beach, FL 33426 walking east on the road. I exited my marked BBPD unit and approached Goldstein as he walked east with his back towards me. I could not see his hands as they were held in front of him, upon commands to turn around he turned and faced me and I observed a small brown dog held between his hands as if it was being choked. The dog appeared lifeless and Goldstein refused multiple commands to place the dog on the ground until he observed Ofc. Halpern behind him with his BBPD issued taser in hand. He then placed the dog down and was detained in handcuffs that were double locked and checked for tightness. Goldstein was then placed into my BBPD patrol unit as Ofc. Jumelles attended to the welfare of the dog. Officers and myself then spoke to the multiple witnesses on scene.

I then approached Witness #1 who advised the following sworn statement. W1 who is the Maintenance Technician for Santorini at Renaissance Commons advised he observed a W/M he identified as Goldstein walking north on the road east of Bonefish Grill with his hands around the dogs neck holding it out in front of him with his arms extended and bringing the dog to his face in order to blow air into its mouth before repeating this cycle until BBPD units arrived.

Witness #2
W2 lives at Building 2 #101 and has a view of the 5th floor balcony from his unit stated he observed suspect strangling the dog over the balcony railing. W2 yelled at suspect to drop the dog and suspect yelled out "Shut the fuck up!". W2 then stated he observed suspect go down to the first floor area holding the dog by the neck area.

Witness #3
W3 lives in Building 2#505 and is directly adjacent to suspect. W3 advised she saw suspect extremely aggressive and screaming, As he strangled the dog over the railing. W3 advised the dog appeared to be in distress yet did not hear any noises from the dog. W3 advised multiple neighbors were yelling at suspect to put down the dog yet he continued to strangle the dog. W3 then saw suspect leaving, and did not observe mouth to mouth at any point.

Witness #4
W4 lives in Building 2 #603 and she stated she heard lots of yelling and commotion and can hear the dog whimpering loudly and possibly alive. W4 stated multiple people told the suspect to bring the dog downstairs and he said, "no!". W4 advised she then saw suspect downstairs continuing to choke the dog while walking west bound.

Witness #5
W5 Lives in 2-511, advised she heard loud screaming and could see the dog lifeless.

Witness #6
W6 lives at 2-403 and advised she heard the dog yelping, and multiple people yelling at suspect. She saw suspect leaving the building holding the dog by the neck and did not observe him giving mouth to mouth.

All statements were recorded via BBPD issued BWC. Property Management provided first floor video surveillance of the incident which i observed.

I advised Goldstein of his Constitutional Rights per Miranda, at which time Goldstein advised he refused to answer any questions and requested a lawyer to be present. I stopped the interview at this time.

The dog was determined to be deceased on scene by BBPD Animal Cruelty investigator Roehrich, L. and taken to Palm Beach County Animal Control for autopsy.

Based on the above investigation, Goldstein, Jonathan L. was placed under arrest pursuant to FSS 828.12.(2) Aggravated Animal Cruelty. Goldstein was processed and turned over to the care, custody and control of the Palm Beach County Jail.
