The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 09/30/2021, at approximately 2113 hours, I affiant observed a red Dodge Challenger, bearing Florida tag HXWV60 (VIN:2C3CDZDJ5GH153976), back into a parked car in front of 401 Parson Av S. The red Dodge Challenger immediately fled the area without attempting to exchange information. The total estimated damage as a result of the traffic accident was \$1,000 (Reference HCSO case #21-655816/ DHSMV #24628408). The affiant conducted a traffic stop on the red Dodge Challenger at the intersection of Oakfield Dr and Corner Dr, a short distance from the accident location. Upon contact with the defendant, the affiant detected the strong odor of an alcoholic beverage emanating from the defendant's breath, observed his eyes to be red/bloodshot and watery, his movements to be slow and lethargic, and his balance to be unsteady. The affiant requested the defendant to perform Standard Field Sobriety Exercises (SFSEs), which the defendant refused to do. The defendant was place under arrest for DUI based on the totality of the circumstances. The defendant was transported to CBT, where he refused to provide lawful samples of his breath after implied consent was read and understood. The defendant was positively identified via his valid Florida driver's license.
