On 06/09/2021, I received National Center of Missing and Exploited Children (NCMEC) Cyber Tip Report #91783555 from the Broward County Sheriff's Office (BSO) South Florida ICAC task force. The Cybertip was reported by the chat application KIK in reference to one of their users who uploaded (3) files that depicted the sexual abuse of a child to another user via KIK. KIK provided the below information:

The two are engaged in sexual intercourse. The male is controlling the child's movements with his hands. The child is blindfolded. The child appears to be 6-7 years of age.

The child's face, chest and vagina are fully exposed. An adult white male is thrusting his erect penis in and out of the female's vagina and anus. The child appears to be approximately 5 to 7 years of age.

KIK provided the users information and IP logs. This information was generated by KIK on 05/30/2021. KIK provided the following information from the suspect's account:

On 07/14/2021, I received subpoena results from Comcast Internet Services. The results indicated the subscriber of IP Address: 174.48.33.25 assigned on 04-16-2021 at 08:57:44 UTC hours and 08:58:07 UTC hours to be: Johnathan Derby with service address 1169 Quaye Lake Circle, Apt. 104, West Palm Beach, FL 33411.

The Comcast IP address was utilized by the suspect to upload the child pornography. The subscriber's name matches the email address that is listed on the suspect's KIK account.

On 07/16/2021, I verified through the Palm Beach County Clerk of Court system that Derby received a traffic citation. The address listed on the ticket for Derby matches the address Comcast Internet services provided, 1169 Quaye Lake Cir Apt. 104, West Palm Beach, FL 33411. On 07/13/2021, Derby was also mailed a hearing notice in reference to the ticket to the same address listed on the ticket. This confirms the suspect is currently residing at 1169 Quaye Lake Circ, Apt. 104 in West Palm Beach.

On 08/17/2021, I obtained a residential search warrant from Honorable Judge James Nutt for the residence. On 08/18/2021, members of the PBSO TAC team and Cyber Crimes Unit met at 0600 hours to review the pending execution of the search warrant. PBSO's TAC team executed the search warrant shortly after.

Detective Borrows and I made contact with Johnathan Derby outside of his residence located at 1169 Quaye Lake Cir, Apt 104, West Palm Beach he agreed to speak with us in my unmarked PBSO vehicle. Post Miranda, Derby admitted that he had KIK and provided the same account information listed in the Cybertip report. He admitted he uploaded the videos that depicted the sexual abuse of children within his KIK account and transmitted it to another user in a chat to get the other user to "indict themselves." He stated he has a pornography addiction but denies being sexually interested in children. Derby admitted he obtained the child pornography from other users who sent links to him to access pornography. Derby stated he stores all of his pornography in the Mega app sorted in several files. I showed Derby sanitized screen shots of the videos he uploaded through KIK, he acknowledged he uploaded the video of the child performing oral sex on the adult male in a child pornography chat group on KIK, but he cannot remember uploading the other two video.

Derby stated he is aware that possessing and transmitting child pornography is illegal. Forensic Detective conducted an on scene preview of Derby's cell phone. Within the Mega application on his cell phone a file labeled "Sort" was located, in this file 3 videos that depicted the sexual abuse of female children ages 5 to 10 were observed.

Derby's iPhone was seized as well as other devices and will later be forensically examined by Forensic Detectives.

Based on my investigation, the suspect did knowingly possess (3) or more images of sexual performance by a child in violation of Florida State Statute 827.071(5).
