The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 08/29/2020 at 0301 hours I responded to Davis BL E and Biscayne Av after Tampa Police Officer Bradley Grange(49381) conducted a traffic stop on a gray 2020 Ford Fusion sedan for speeding. Upon contact with the driver of the vehicle, defendant Jonathan Mendall Long, Officer Grange observed signs of impairment. Suspecting that the defendant was impaired Officer Grange requested a DUI unit. Upon my arrival I made contact with the defendant and immediately observed that he had extremely bloodshot glassy eyes. Then as I explained to him who I was and why I was there I detected a distinct odor of an alcoholic beverage. I then asked the defendant to exit his vehicle and he complied. Once out of his vehicle I continued to detect the distinct odor of an alcoholic beverage. The defendant then refused to perform the SFSEs. At which time I placed him under arrest for DUI based upon all of my observations made thus far in my investigation. The time of arrest was 0312 hours. I then transported the defendant to the HCSO/CBT Facility where he refused to submit to a breath test. Implied Consent was read at 0345 hours. I identified the defendant with a FL DL.
