I approached the Florida registered vessel.

26' SLP Vessel

The operator of the vessel was registered owner and identified by a photo on his Florida Drivers Licenses (S100-420-88-030-0) Mr. Jonathan Sabia.

I identified myself as State Law Enforcement and told Mr. Sabia I was going to conduct a vessel safety inspection. I immediately noticed that Mr. Sabia had drowsy blood shot eyes. There was also an odor of an unknown alcoholic beverage emitting from his person. I asked Mr. Sabia to show me a PFD on board for everyone, sound producing device, type 4 throw able floatation device, flares and fire extinguishers. Mr. Sabia was able to provide me with the correct amount of PFD's but could not provide me with a type four throw able device or fire extinguishers. Mr. Sabia searched his vessels aimlessly, checking the same compartments more than once and asking me to repeat and inform him on which safety gear I was requesting again.

At the end of the inspection, I asked Mr. Sabia if he could board my patrol vessel to preform some task to make sure he was safe to continue operating his vessel. Mr. Sabia stated he could and begin to climb aboard my vessel. I had to hold him upright so he would not fall into the water while he kept repeating "I'm Good, I'm Good".

Through pre-task questioning I found that he was not sick or injured, he is under the care of a doctor or dentist, not on any medication or drugs, did not have any physical defects or disabilities, did not have any defects with his eyes, and was not wearing contacts.

I read the instructions for the Horizontal Gaze Nystagmus (HGN) task and administered the task with the following observations:

- *No resting nystagmus, equal pupil size, equal tracking of both eyes.
- *Lack of smooth pursuit in the left eye (1) and in the right eye (2).
- *Distinct and sustained nystagmus at maximum deviation in the left eye (3) and in the right eye (4).
- *Onset of nystagmus prior to 45 degrees in the left eye (5) and in the right eye (6).
- *Onset of nystagmus at approximately 35 degrees.
- *Vertical nystagmus not present.

I observed a total of 6 clues on the HGN task. Mr. Sabia failed to keep his head still while preforming the task. Performance with 4 or more clues indicate impairment beyond the legal limit.

I placed Mr. Sabia in the starting position for the Finger to Nose (FTN) task, explained and demonstrated the task and administered the task in order of "left, right, left, right, left, with the following observations:

- *Unable to follow instructions (1) for not remaining in the starting position.
- *Started at the wrong time before being told.(2)
- *Did not close eyes.(2)
- *Did not tilt head.(3)
- *Opened eyes during task.

I observed a total of 14 clues to FTN task. Performance with 9 or more clues indicates impairment beyond the legal limit.

I placed Mr. Sabia in the starting position for the Palm Pat (PP) task, explained and demonstrated the task and administered the task with the following observations:

- *Unable to follow instructions for not remaining in the starting position
- *Started at the wrong time before being told.
- *Did not count as instructed.
- *Rolled hands. (1)
- *Chopped pat (2).
- *Other improper pat.
- *Did not increase speed (3).

I observed a total of 3 clues on the PP task. Performance with 2 or more clues indicates impairment beyond the legal limit.

I placed Mr. Sabia in the starting position for the Hand Coordination (HC) task, explained, demonstrated the task three times and administered the task with the following observations:

- *Unable to follow instructions for not remaining in the starting position. (1)
- *Started at the wrong time before being told.
- *Task 1: Improper touch (1).
- *Task 2: Improper count (2). Improper touch (3). Improper return (4).
- *Task 3: Improper count (5). Improper touch (6). Did not return left fist to chest (7).
- *Task 4: Improper position (8).

I observed a total of 8 clues on the HC task. Performance with 3 or more clues indicates impairment beyond the legal limit.

Mr. Sabia was placed under arrest for boating with normal faculties impaired. Mr. Sabia was transported by patrol vessel to Silver Palm Boat Ramp where he refused to provide a sample of his breath to determine his alcohol content. Mr. Sabia was then transported to Palm Beach Central Jail by Boca Raton PD.

Copies of Mr. Sabia's citations were left with the jail staff.
