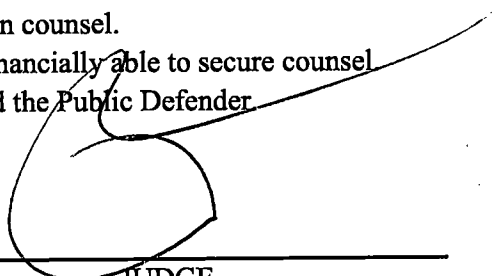
ADVISORY AND SOLVENCY HEARING

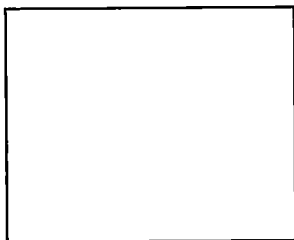
