On the above date and time, I was in service in Palm Beach County, FL assigned to the north end of District 3 for the Palm Beach County Sheriffs Office as a Deputy. I was dispatched to 220 North Four Seasons Road, Palm Beach Gardens, FL 33410 in reference to a stabbing. Information was received from dispatch, that the complainant, Judd Zagata, stated that his roommate, Jordan Amit stabbed him. Mr. Zagata advised that he was outside and his roommate was still inside of the trailer inside of his bedroom. While on the way to the address, dispatch had received a call from the girlfriend of Jordan Amit, stating that she was locked inside of the bedroom with Jordan Amit and he has a stab wound in his leg. Upon arrival, D/S A. Perez #14622 and I observed Mr. Zagata in the road and as we approached, he showed us his injuries. He advised that he was stabbed with a black pocket knife. There was a stab wound in the tricep area of his left arm and a stab wound near his lower back just at the top of his buttocks. Both wounds appeared very deep and he had blood over his person. EMS was called to the scene for his injuries. Mr. Zagata informed us that the confrontation occurred between him and Mr. Amit and that there was also a separate incident nearly 24 hours before this, when the PBSO had to respond to their residence. I had dispatch make contact with the girlfriend of Mr. Amit over the phone, to advise her to step outside. The girlfriend was identified as Taylor Adelstien, who informed us that her boyfriend was now sitting on the couch in pain. We made entry into the residence and saw Mr. Amit sitting on the couch without a shirt on. He had smeared blood on his thigh area of the left leg and a small scratch that was slightly bleeding on his left achillias. Mr. Amit appeared under the influence of an unknown drug, he was slow with his speech and appeared sleepy. He complained of a stab wound but he had none. D/S A. Perez #14622 asked Mr. Amit where the knife was and he advised in his pocket. A black in color pocket knife was found in his right pocket. There was no blood on the knife, it appeared washed off, as there was water on the blade. EMS personnel was called to the scene for Mr. Amit as well. While outside, he threw up several times in the driveway. Upon the arrival of EMS, Mr. Amit was placed in handcuffs to the front, checked for proper fit and tightness and Transported to St. Marys Medical for medical clearance. During my investigation, I found Mr. Amit committed the act of Aggravated Battery with a Deadly Weapon, when he used his pocket knife to stabbed Mr. Zagata twice. Upon release from the hospital, Mr. Amit was transported to the Palm Beach County Jail for Booking.
