The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On the listed date and time, at the listed offense location, the Defendant and the Victim were involved in a verbal altercation. The altercation became physical when the Defendant intentionally and violently began pushing the Victim against his will multiple times. The Victim fell backwards onto his bed after each push. The Victim was able to flee from the Defendant to a separate room in the residence. While fleeing the Defendant again pushed the Victim in his back causing him to lose balance and stumble forward. The Victim fled to a room where the Witness was located, the Defendant continued to pursue the Victim and again pushed him causing him to lose balance and fall backwards. The Defendant was consuming alcoholic beverages prior to the incident. The incident was not the result of disciplinary action. The Victim is the juvenile son of the Defendant. The Victim and Defendant live together as a family. The Victim identified the Defendant as the person who committed the offense. The Victim positively identified the Defendant via his Florida DHSMV photo.
