The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On the listed date and time, Deputy Sinclair #260038 contacted the driver after being dispatched to a traffic crash where a vehicle drove into a body of water. When initial contact was made, the driver was actively attempting to drive the vehicle out of the water as it was stuck in mud, in actual physical control of the vehicle. Upon contact with the driver, the driver emitted an odor of an alcoholic beverage from his breath, he had slurred speech, he related it was his birthday and he had been drinking, had bloodshot and watery eyes, and unstable balance. Field sobriety exercises were conducted and impairment was observed. The driver was arrested for DUI and refused breath test after Implied Consent warning was read and understood. The driver admitted having consumed 5 Bud Light beers prior to the traffic crash tonight during post-Miranda interview. The driver was identified via a valid Florida DL. A DAVID query of the driver discovered one prior guilty DUI conviction on 01/08/2019.
