<p>On 8/13/2021 at approximately 0247hrs I was conducting speed enforcement in the area of W Indiantown Rd and Maplewood Drive, Jupiter, Palm Beach County, Florida. I was in full police uniform with my department issued Axon BWC activated and I was operating a Jupiter Police Department unmarked vehicle with red and blue emergency lights and siren equipped. While monitoring west bound traffic, I observed a red sedan bearing FL tag PANE34 going west bound at approximately 70mph. My vehicle mounted Stalker Radar provided a true speed of 72mph in a posted 45mph zone with a clear tone. Based on the aforementioned traffic violation, I turned around on the vehicle and attempted to conduct a traffic stop by utilizing the red and blue emergency lights and siren. The vehicle came to a complete stop near the Shell Gas Station at 6751 W Indiantown Rd, Jupiter, Palm Beach County, Florida.</p> <p>I approached the vehicle and made contact with the sole occupant and driver of the vehicle who identified herself to be WF Jordan Z. Bufalo (6/8/1999) and provided her Florida Class E Driver License. Upon making contact with Bufalo, I noticed the strong odor of an unknown alcoholic beverage coming from her person. Bufalo also had slurred speech and was slow to react to requests for paperwork. Bufalo was unable to provide insurance or registration for the vehicle. While speaking to Bufalo I noticed the odor of an unknown alcoholic beverage grew stronger. I asked Bufalo where she was coming from and she initially stated work but stated after work she went to a local bar in Jupiter. Bufalo was asked how much she had to drink and she stated that she had a beer. When asked on a scale of 1-10 with 1 being completely sober and 10 being the most drunk she has ever been in her life on where she was. Bufalo stated at a 3-4. Bufalo was asked if she thought she should be driving and she stated she felt fine and wasn't at a 5-6 so she should be fine to drive. Bufalo also said she would be willing to do field sobriety exercises if needed.</p> <p>At this point while waiting for another officer to arrive on scene, I requested Bufalo's</p>

<p>registration and insurance again but she was ultimately unable to provide the requested information. Once another officer arrived on scene, I relocated my patrol vehicle a short distance into the parking lot of the Shell Gas Station where there was a white roadway line painted on the ground for use during SFSTs.</p> <p>I then returned to the vehicle to make contact with Bufalo. I asked Bufalo to exit the vehicle and she complied. Bufalo was swaying while standing still. Bufalo walked over to the front of my patrol vehicle as requested. Bufalo explained she did not have any medical issues that would preclude her from completing SFSTs and was not under the care of a doctor or a dentist. Bufalo also explained she did not have any issues with her eyes. Based off of my investigation to this point, I requested that Bufalo complete SFSTs and she agreed.</p> <p>Bufalo performed poorly on SFSTs and I subsequently established probable cause to arrest and charge Bufalo with DUI pursuant to Florida State Statutes. See DUI PC for more information regarding SFSTs.</p> <p>Based upon my entire investigation up to this point including the driving pattern, statements made by Bufalo, my observations, and Bufalo's performance on SFSTs, she was placed under arrest. Bufalo was secured in handcuffs which were double locked and checked for spacing and was searched by Officer Anderson #313. Bufalo was later secured in the back seat of my patrol vehicle and secured by the seat belt. Bufalo was asked roadside to provide a breath sample and she agreed. Therefore, Bufalo was transported to the Palm Beach County Jail BAT Facility where after a 20 minute observation period she agreed to provide a breath sample. Bufalo provided breath samples of 0.153 and 0.157 at 0409hrs and 0412hrs. Bufalo was read her Miranda Warnings from a preprinted paper and stated she did not wish to answer questions without speaking to a lawyer.</p> <p>Bufalo was secured in a holding cell while the appropriate paperwork was completed for booking her into the Palm Beach County Jail. Bufalo's vehicle was removed from the scene by North County Towing in Jupiter Florida.</p>
