

Moments later, the same employee, Richard Zebart was having a verbal argument with the same male and a female at the front door.</p> <p>W/M later identified as Jorge Barragan and W/F Mary Arteiro were actively refusing to leave the business. Zebart informed me that he would like them to be trespassed. Both individuals were slurring their words and stumbling around. I informed Barragan and Arteiro that Tin Roof wants them to leave the area and if they continue to refuse, they will be placed under arrest. Arteiro stated "arrest me," then proceeded to stick her arms out, waiting for me to cuff her. Once I grabbed her left arm and attempted to place it behind her back, Arteiro tensed up and pulled away. At this time, Barragan proceeded to get behind Arteiro's back to try and pull her away from officers. Myself and Ofc Belman escorted Arteiro to the ground and were able to get control.</p> <p>Ofc Butner and Sgt Saraceni were able to escort Barragan to the ground. While placing Arteiro into my vehicle she proceeded to kick the door open with her foot.</p> <p>Based on the above stated facts, probable cause exists to charge both, Jorge Barragan and Mary Arteiro with one count of Trespass after Warning, a violation of FSS 810.09(2B), one count of resisting without violence, a violation of FSS 843.02 and one count of disorderly intoxication, a violation of 856.011.</p>
