The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On 01/17/2021, at approximately 0247 hours, I was traveling northbound on N Dale Mabry Hwy in my unmarked patrol vehicle. I observed a gold BMW 528i, bearing Florida tag NZIC62, to be traveling in front of my patrol vehicle and weaving within it's lane. I paced this vehicle and measured it's speed to be approximately 63 MPH in a posted 45 MPH speed zone. I conducted a traffic stop on this vehicle at the intersection of Lake Carrol Way and N Dale Mabry Hwy. Upon contact with the defendant, I observed him to have bloodshot glassy eyes and the distinct odor of an alcoholic beverage emitted from his breath as he spoke. The defendant was asked to participate in the Standardized Field Sobriety Exercises, which he agreed. During the exercises, the defendant showed signs of impairment and was placed under arrest for DUI. Implied consent was read and the defendant refused to provide a lawful sample of his breath. The defendant was positively identified via his Florida driver's license.
